Subject **Customer Advisory: Updates to EU Emission Trading System (ETS)**

Dear valued Customer,

In our advisory dated December 5th, 2024, we provided key information regarding anticipated changes in the EU Emission Trading System (ETS)-related surcharges.

Below please find an overview of the upcoming surcharges, valid from January 1st until March 31st, 2025, applicable to major trades impacted by EU ETS regulations. These changes are based on carriers' re-evaluation of the ETS charges to ensure full compliance with the EU Fuel Maritime Regulation.
