Stating that the organization is subject to the provisions of this regulation and that the notification specified in 7th article has been made by using the notification system of the Minister of Environment, Urbanization and Climate Change and in case it is a top level organization, safety report that it is obliged to be prepared in accordance with 11th article has been prepared

Our organization is subject to the provisions of this regulation. We have made the declaration specified in 7th article of the regulation by using the notification system of the Minister of Environment, Urbanization and Climate Change. According to the notification made, our organization is a low-level organization and we have prepared the major accident prevention policy document that we are obliged to prepare in accordance with 10th article of the regulation.

3. Explanation of the activities carried out in the organization in simple language,

Our company carries out storage activities of products such as PVA and acrylic based adhesives, industrial adhesives, liquid metal chemicals (Galvano plasti auxiliary, phosphating agent, degreasing product etc.), automotive sealant and sealing product, acrylic sealant, metal surface cleaning chemical (powder), silicone based, polyvinyl chloride (PVC) adhesive and rubber (neoprene) based adhesive product at the above mentioned address.

4. Known names of the substances specified in Annex-1 Parts 1 and 2 that may cause a major accident and simple explanations of the basic hazardous properties of these substances,

There are 4 main groups of chemicals that can cause a major accident in the organization: flammable, oxidizing, toxic and harmful to the aquatic environment.

5. Information on what to do in the event of a major accident:

Our organization conducts drills at least twice a year to prepare for emergencies. All infrastructure preparations and teams have been established for the Emergency Action Plan and response. Teams have been specially trained in this regard. In case the Emergency Plan is insufficient to respond, the Provincial Disaster and Emergency Directorate will be notified and response activities will be carried out in accordance with the Provincial Disaster Response Plan under the coordination of the Provincial Disaster and Emergency Directorate. In addition, the

Provincial Directorate of Environment, Urbanization and Climate Change will be informed about the accident.
